

Wolfpack Wrestling Parent Information

TCNE will offer youth wrestling for ALL (Girls and Boys) Tri-County PK-6th graders. We will teach the fundamentals of folkstyle wrestling. We will have two different options for classes. Practice will be held at the Allen wrestling room, just east of the preschool room behind the school, as of now. Generally, from December-March there will be tournaments every weekend. Tournament costs usually range from \$15-25 per wrestler per tournament. Your child does not have to compete in every tournament; parents can pick and choose what tournaments they attend. A class will be held at the beginning of wrestling season teaching parents how to use **Trackwrestling** (this is where you will register your wrestler for tournaments). If your wrestler happens to qualify for the state wrestling meet in Grand Island this will be paid for by the youth rec.

**During practice the door to the school will be unlocked for parents to use the commons area.*

— **Option 1:** PK-Kindergarten athletes. Wrestling shoes are not required. Children can wrestle in socks. Singlets will not be provided. Students will only compete in the TCNE vs. Wakefield duel held at the Wakefield civic center. Practice will be every other week.

— **Option 2:** Normal competitive classes will be open for 1st-6th graders. The season will run from the first week in November through the middle of March. We will practice Tuesday and Thursday evenings from 6:30pm to 7:45pm. Wrestlers will be asked to have wrestling shoes before competing in the first tournament. Singlets will be provided for tournament use only. Headgear is optional. If enrolled in this class your wrestler will be required to compete at the district tournament at the beginning of March, but all other tournaments are optional. For example, due to the length of the season you may opt to only compete in the Nebraska tournaments Jan-March and not the Iowa tournaments in Nov-Dec.

— **Option 1:** PK-Kindergarten. Wrestling shoes are not required. Children can wrestle in socks. Singlets will not be provided. Students will only compete in the TCNE vs. Wakefield duel held at the Wakefield civic center.

Cost \$15 per child

(Allen families make checks to Allen Youth Rec; Emerson families make checks to Emerson Sports Association)

— **Option 2:** Normal competitive classes for 1st-6th graders. You choose and pay for the tournaments you attend.

Cost \$20 per child + \$40 deposit for the singlet that you will get back when you turn it in at the end of the season (two separate checks please!)
